ELIGIBILITY: Trial class and JHD/HCT dogs must be 9 months or older. In trial classes, bitches in heat will run in the order drawn. In test classes, bitches in heat will run last. Non-competing runs will be allowed; such runs will be judged solely as exhibition only and are not eligible for any placements or prizes. A dog may enter at any level for which it is trained. No title is a prerequisite for another. A dog may not be entered in both a test class and a trial class on the same day. A dog may be entered in different levels for different stock.

Herding Ranch Dog Course: The course for the Herding Ranch dog is included as part of this form. We will be using 5 sheep for HRD sheep

Herding Trial Arena Dog (HTAD) Course #3: We will be using a GATHER for stock in AM and TAKE PEN in PM. Ribbon-removal/shed (sheep) will be used as the sort for Advanced handlers (HTAD III). The free standing pen will be used at all levels.

Junior Herding Dog/HCT: Sheep will be used for the JHD/HCT runs

AWARDS: 1st- 4th place and qualifying ribbons will be awarded per class. High Score Sheep, High combined and High in Trial will be awarded each trial.

DIRECTIONS TO FACILITY:

ACTUAL MAILING ADDRESS is 265 Roper Lane. HESPERUS, CO. The facility is located about 40 minutes southwest of Durango, CO

Use this address when using google maps, mapquest and other driving direction applications

Please drive slowly on Roper Lane as this is a private road.

From Durango:

Take Hwy 160 west to the intersection of Wildcat Canyon (CR 141). Turn left onto Wildcat and follow until it dead-ends into CO Hwy 140 (about 18 miles). Turn left and follow Hwy 140 for about 5 miles. You'll see Ft. Lewis Elementary school on the left. Go about $\frac{3}{4}$ of a mile further and you'll see a sign for Marvel. Turn left onto CR 134. It's about 2 miles to Marvel – go straight through the main intersection and stay on 134 for another mile. (The pavement ends) You'll come to another intersection. CR 135 is on your right – Roper Lane is on your left. Turn left onto Roper Lane and go $\frac{1}{2}$ mile straight back to the grayish house on the left.

From Cortez:

Take Hwy 160 east to Hesperus. Turn right onto CO Hwy 140 and go about 18 miles. You'll see Ft. Lewis Elementary school on the left. Go about $\frac{3}{4}$ of a mile further and you'll see a sign for Marvel. Turn left onto CR 134. It's about 2 miles to Marvel – go straight through the main intersection and stay on 134 for another mile. (The pavement ends) You'll come to another intersection. CR 135 is on your right – Roper Lane is on your left. Turn left onto Roper Lane and go $\frac{1}{2}$ mile straight back to the grayish house on the left.

From Farmington:

Take NM Hwy 170 towards Hesperus/Durango – it turns into CO Hwy 140 at the state line. Go through Red Mesa (about 7 miles) One mile past Red Mesa, you'll see a sign for Marvel. Turn right onto CR 100 and proceed about two miles to the intersection in Marvel. Turn right at the stop sign onto CR 134 and stay on 134 for another mile. (The pavement ends) You'll come to another intersection. CR 135 is on your right – Roper Lane is on your left. Turn left onto Roper Lane and go $\frac{1}{2}$ mile straight back to the grayish house on the left.
